Minutes of the meeting held on 21.10.2025 Presided by the Hon'ble Minister for Public Works Department, Puducherry and chaired by the District Collector-cum-Chairperson, Puducherry District Disaster Management Authority, to review the action taken to face the ongoing North East Monsoon, 2025, at SEOC, 06.00 PM

The District Collector-cum-Chairperson, Puducherry District Disaster Management Authority, Puducherry, welcomed all the Officers present and informed that the meeting would.

2. The District Collector, Puducherry, sought the particulars about the action taken on the preparatory activities discussed during the previous preparatory meeting. Further, being performed by all the ESF leaders / line departments and instructed for further actions as follows:

- ➔ Control Rooms to be established to function 24 X 7 till the end of the NEM, 2025-26 and contact numbers of the officials deployed to be shared to the SEOC along with duty roster.

Action by: PWD, Electricity, Forest, Local Bodies, Fisheries & Taluk Tahsildars.

- ➔ Watch the low-lying areas consistently.

Action by: PWD, Local Bodies & Taluk Tahsildars.

- ➔ 1. Any specific/ peculiar issues to be addressed immediately.
2. Drinking water to be chlorinated as per requirement.
3. To strengthen weak points of river bank and irrigation channels/Canal/ Drains.
4. To deploy water pumps to bail out the water inundation from low lying areas & channel.
5. Sufficient JCBs to be provided to clear the debris at the earliest.

Action by: PWD & Local bodies.

- ➔ Wherever it is felt necessary, evacuation to be carried out and foods may be arranged locally.

Action by: SDMs.

- ➔ Requisite Vehicles to be arranged upon request of the SDMs for relief & evacuation.

Action by: Transport Department.

- ➔ 1. Requisite Foods to be arranged upon request of the SDMs. To be ready accordingly.
2. To facilitate fuel from various pumping stations in case of shortage. To identify fuel stations for uninterrupted fuel supply for pump houses and for government institutions.

Action by: Dept. of Civil Supplies & Consumer Affairs.

- ➔ 1. No new banners/hoardings to be permitted. As much as possible, remove the existing banners.
2. Provide generator sets to every water pump house to ensure seamless drinking water supply.
3. Desilting of left out channels to be carried immediately.

Action by: Local bodies.

- 1. Pruning of trees to be carried out immediately after the rain stops.
2. Each one Snake catcher to be allotted per Taluk and contact numbers to be shared with the State & Taluk EOCs.
Action by: Forest Dept.
- 1. Electricity control room to be more active in attending complaints.
2. To issue necessary advisories to the public.
Action by: Electricity Dept.
- Deploy a nodal officer on 24 X 7 basis to the SEOC who is responsible to disseminate the complaints for immediate disposal.
Action by: PWD, Local bodies, Electricity, Health, Forest, Transport.
- Provide Sand bags to the Electricity Department and river bunds wherever necessary.
Action by: PWD.
- 1. To co-ordinate with Forest and PWD for removing fallen trees and vulnerable trees.
2. To mobilize necessary resources and man power for search & rescue operations.
Action by: Fire Service.
- 1. To ensure adequate medicines and vaccines are available in all PHCs/CHCs for prevention and control of outbreak of diseases / epidemic.
2. To ensure that identified locations of mosquito breeding points and low lying flooding areas are properly treated to prevent vector borne diseases along with the assistance of the Local bodies, wherever necessary.
3. Necessary IEC material for water borne diseases to be kept ready.
4. To ensure ambulance facilities are ready for emergencies.
5. To issue necessary advisories to the public.
Action by: Health & Family Welfare.
- 1. To keep all schools opened during emergency.
2. To provide the contact list of the person in-charge of Schools identified as Shelters.
Action by: Directorate of School Education.
- To prepare the area-wise list of pregnant and lactating women for shifting during emergencies and to provide a single point of contact.
Action by: Women & Child welfare.
- 1. To co-ordinate with NGOs for resource mobilization to assist in managing disasters.
2. To identify and keep the list of the disabled and elderly in vulnerable areas.
Action by: Social welfare.
- To issue necessary advisories to the Farmers.
Action by: Agriculture Dept.
- 1. To identify shelter locations for domestic animals, cattle and necessary emergency stocking of medicines and fodder in the immediate vicinity of such shelters.
2. To issue necessary warning / instructions on time.
Action by: Animal Husbandry Dept.

- 1. To ensure availability of Public Address System in patrolling / SHOs vehicles.
2. To ensure deployment of police personnel to handle wireless messages in the SEOC.
3. To utilize effectively the equipment procured for Disaster Management.

Action by: Police Dept.

- 1. To disseminate weather warnings to fishermen through VHF radio communication, public address system to all fishermen particularly those engaged in fishing in the harbour. Warning messages should also be sent through the local cable TV network / FM.
2. Fishing boats to be kept ready for rescue operations.

Action by: Fisheries Department.

- To co-ordinate with Fisheries Department for rescue operations.

Action by: Indian Coast Guard.
